HILL COUNTRY TELEPHONE COOPERATIVE, INC. Annual Membership Meeting Held on October 2, 2023 6:00 p.m.

The Annual Membership Meeting of the Hill Country Telephone Cooperative, Inc. (hereinafter called the Cooperative), was recorded on Tuesday, September 12, 2023, in the Board Room of the Headquarters Office Building in Ingram, Texas, and the video was posted on the Cooperative's website on Monday, October 2, 2023.

1. CALL TO ORDER:

The Annual Membership Meeting was called to order at 6:00 p.m. by the presiding officer, President, Kari Potter, who officiated as Chairperson throughout the meeting.

2. <u>INVOCATION</u>:

Pastor Katie Rode of Immanuel Lutheran Church in Comfort, Texas gave the invocation.

3. PLEDGE OF ALLEGIANCE:

The Pledge of Allegiance was presented by SSG (Retired) Shilo Harris, in a prerecorded video.

4. <u>NATIONAL ANTHEM</u>:

5. INTRODUCTION:

6. PRESIDENT'S REPORT:
