By signing this form and submitting a bid, you agree to the following terms and conditions:

Blind Bid Auction: This is a closed, blind bid auction. Bidders will not have access to other bid amounts. Only the highest bid for each vehicle will win.

One Bid Per Vehicle: Each bidder may submit only one bid per vehicle. Multiple bids will result in the disqualification of all submitted bids by that bidder.

Binding Bid: All bids are binding and cannot be withdrawn or amended once submitted. By submitting a bid, you agree to purchase the vehicle if your bid is selected as the winning bid.

Bid Submission: All bids must be submitted via email to hctcbid@hctc.coop before 5:00 PM on December 4th, 2024. Late bids will not be considered.

Content Submission: In addition to this form, please include all supporting documents and pictures that detail the vehicle when submitting your bid via email. These materials provide essential information for evaluating the condition and features of the vehicle.

Notification of Winners: Winning bidders will be notified by email and phone on December 6th, 2024. If you do not receive notification by this date, your bid was not selected.

Payment and Transfer: Winning bidders must complete payment and any required documentation within 7 business days of notification. Accepted payment methods include cashier's check or cash. Failure to complete payment will result in forfeiture of the vehicle and the next highest bid may be considered.

Vehicle Pickup: Vehicles must be picked up within 10 business days after payment is completed. Pickup will occur at HCTC, 220 Carolyn St W, Ingram, TX 78025, and the winning bidder must provide proof of payment and valid identification at the time of pickup.




